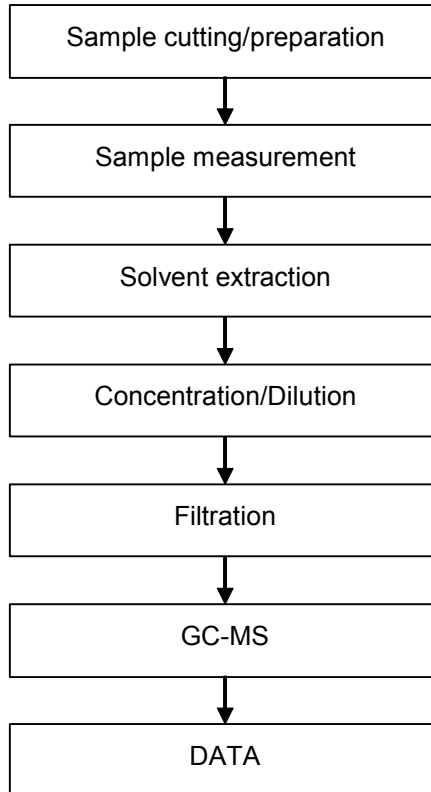

### Phthalates Testing Flow Chart

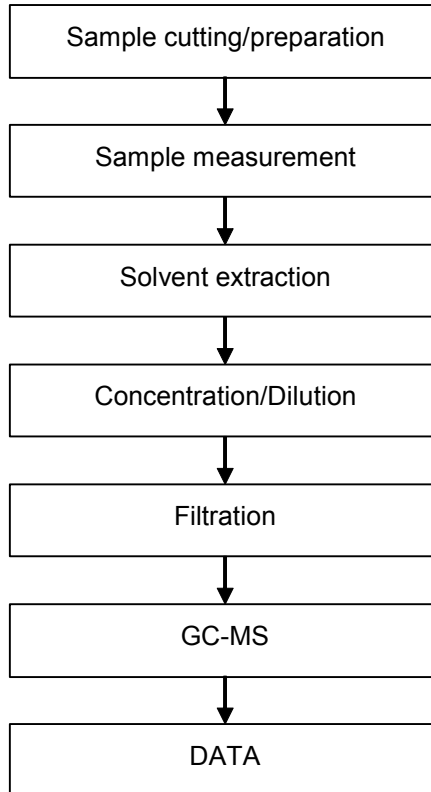

**HBCDD Testing Flow Chart**

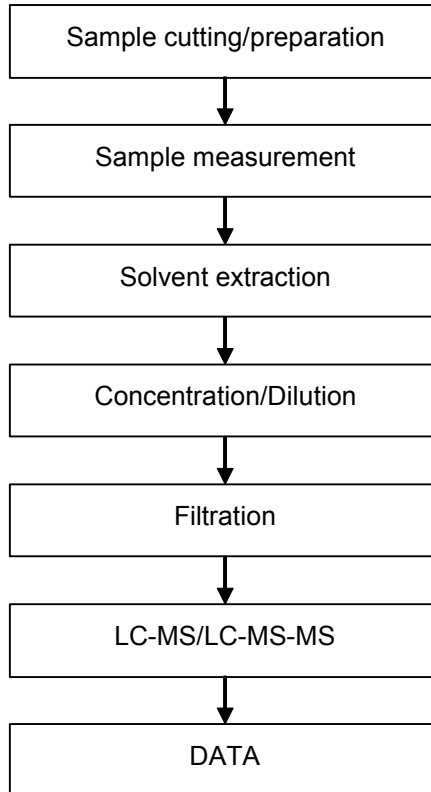

PFASs/ PFOS/PFOA Testing Flow Chart

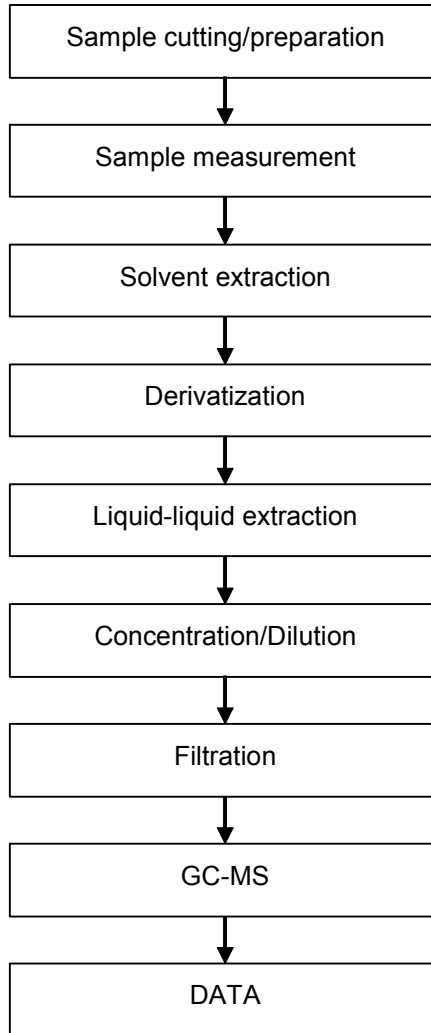

### Organotin Testing Flow Chart



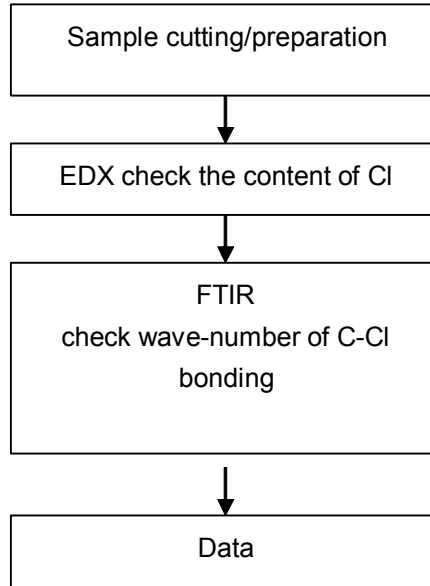

### PVC Testing Flow Chart

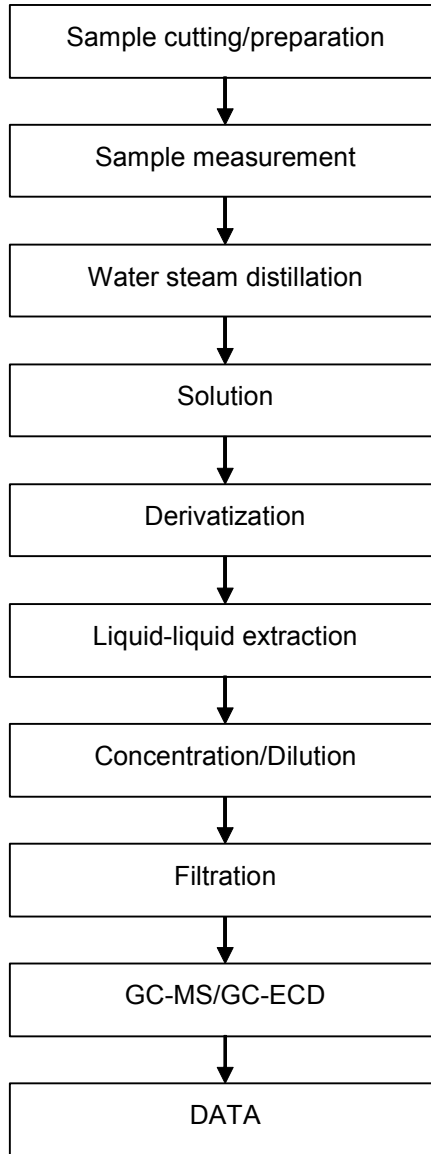

### Chlorinated phenol Testing Flow Chart

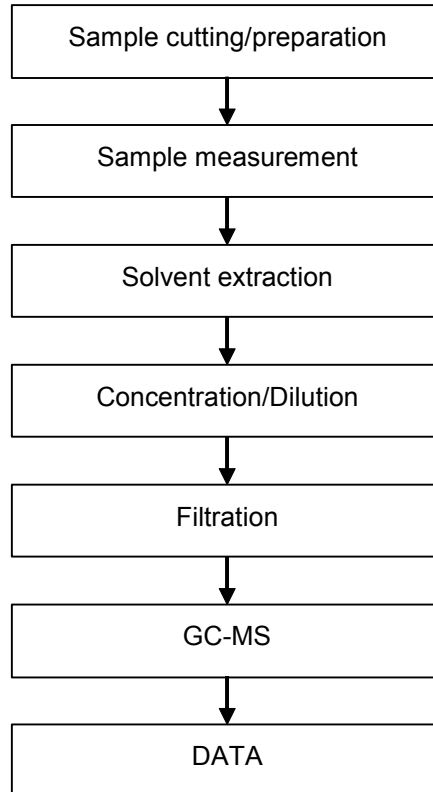

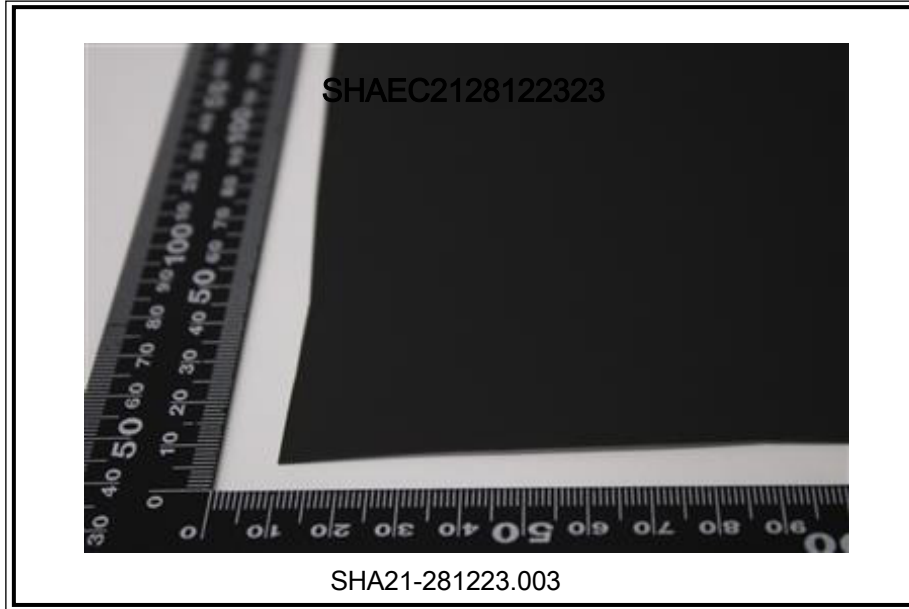
**DMF (Dimethyl fumarate) Testing Flow Chart**
