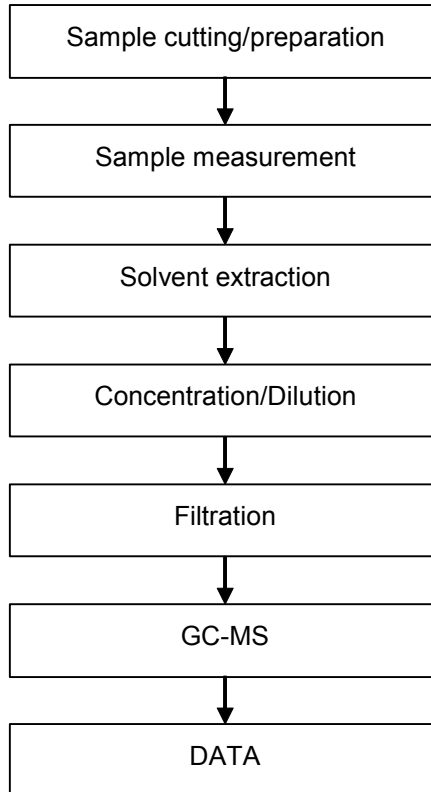

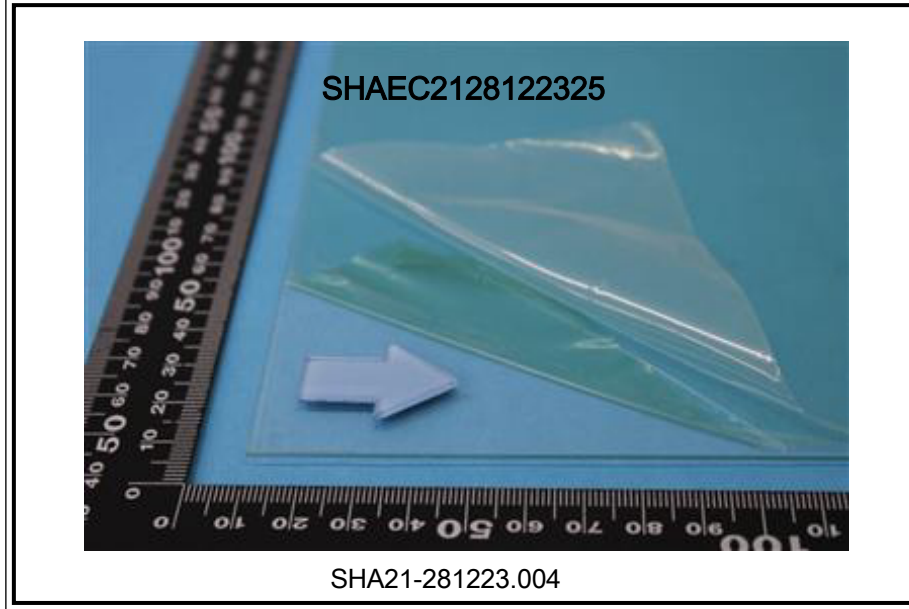
PAHs Testing Flow Chart
